

## ENVIRONMENTAL LABELING OF PACKAGING

Dear Customer, following the legislative decree, which can be found below, Nadella S.r.l. informs you that it is using, where possible, the printing of the required label according to the graphics shown below on the packaging used in shipments:



If the structural characteristics of the packaging do not allow for such a graphic enhancement, corresponding descriptions will be made in the material sorting, in the transport documents (please refer to the table below) and/or in the summary that can be downloaded from our website - <https://www.nadella.com/group-of-companies/quality-and-environmental-management>

As of 1 January 2024, mandatory environmental labelling of packaging came in place.

To help you, below you will find a handy list of the most important things you need to know in order to properly comply with the regulations:

**PACKAGING SUBJECT TO THE OBLIGATION:** All packaging released for consumption within the national territory is subject to the environmental labelling obligation

**PACKAGING EXCLUDED FROM THE OBLIGATION:** Packaging intended for other countries is excluded from the labelling obligation (it must be subject to the specific regulations of the country of destination). Packaging destined for foreign countries must therefore be accompanied by appropriate documentation certifying its destination, or by transport documents and/or technical data sheets containing composition information.

**LABELLING INFORMATION FOR PACKAGING INTENDED FOR B2B:** Packaging intended for B2B must mandatorily include, for each manually separable component, the coding of the composition materials in accordance with Decision 129/97/EC. All other information, including that relating to separate collection, is voluntarily applicable.

**LABELLING INFORMATION FOR PACKAGING INTENDED FOR B2C:** Packaging intended for B2C must mandatorily show for each manually separable component the identification coding of the packaging material according to Decision 129/97/EC and the collection information.

**PACKAGING WITH NON-MANUALLY SEPARABLE COMPONENTS:** Packagings with a main body (e.g. cardboard box) and other ancillary components that cannot be separated manually (e.g. staple), must be labelled with the material identification code of the main body, and the collection markings (which follow the material of the main body).

**PACKAGING WITH MANUALLY SEPARABLE COMPONENTS:** If the packaging system provides for manually separable components from the main body, each of these must necessarily bear the alphanumeric coding as per Decision 129/97/EC and the collection information. The environmental labels of the main body and of the different manually separable components constituting the sales unit should be affixed to each component.

**LABELLING COMPOSITE PACKAGING:** For the identification of the material, the prevailing C/material + number associated with the coupling plastic, paper and steel should be provided. Since Decision 129/97/EC does not provide for any numbering associated with this pairing, it is suggested that the numbering "86" be adopted, i.e. the first available numbering that does not identify any specific pairing and can therefore be adopted in these cases.

**NEUTRAL PACKAGING:** The regulation does not exclude neutral packaging from the obligation. However, in view of the difficulties encountered by operators, both economically and structurally, in meeting the obligation, it has been decided that for this type of packaging, the identification of the material of composition of the packaging is considered fulfilled if the mandatory information required by paragraph 5 of Article 219 of the TUA, is conveyed and communicated through external media (in the case of neutral packaging e.g. DDT), or digital channels (such as App, QR code, bar code, etc.), and if it is not possible even through these tools, to make it available through websites.

**PACKAGING COMBINED WITH COMBINED MATERIALS:** paper-based composite packaging (and/or with components of different materials which cannot be separated manually) with a percentage of the cellulose fraction between 60 and 95% of the total weight of the pack à Indicate to the consumer to separate the packaging into the

separate collection for paper packaging whereas paper-based composite packaging (and/or with components of different materials which cannot be separated manually) with a percentage of the cellulose fraction of less than 60% of the total weight of the pack à Indicate to the consumer to separate the packaging into the separate collection for paper packaging.

GRAPHIC FORM OF THE LABEL: The standard requires all packaging to be appropriately labelled, i.e. in the form and manner of graphics and presentation freely chosen, as long as they are effective and consistent with the objectives envisaged by Art. 219, subsection 5. The regulation does not provide specific indications regarding the graphics, colours and dimensions of the labelling.

ENVIRONMENTAL LABELLING OBLIGATIONS AND RESPONSIBILITY: Environmental labelling is a shared activity between packaging supplier and user, which operators may find it necessary to regulate and formalise through agreements between the various parties involved.


